ADMINISTRATIVE ITEM

TITLE: DESIGNATION OF AN OFFICIAL FOR CALIFORNIA DEPARTMENT OF FINANCE INQUIRES.

RECOMMENDATION:

Adopt Resolution No. 004, "A RESOLUTION OF THE OVERSIGHT BOARD OF THE SUCCESSOR AGENCY TO THE PALM SPRINGS COMMUNITY REDEVELOPMENT AGENCY DESIGNATING AN OFFICIAL TO THE CALIFORNIA DEPARTMENT OF FINANCE AND OTHER MATTERS PERTAINING TO POSTING ACTIONS OF THE BOARD."

BACKGROUND AND ANALYSIS:

California Health and Safety Code § 34179(h) requires the Oversight Board to designate an official to whom the California Department of Finance may make inquiries and requests to review actions taken by the Board.

Staff has prepared a resolution designating the Clerk/Secretary as the Board designee, and included all the information required by law.

Additionally, the Code requires the Oversight Board to post certain information on the agencies webpage for review by the Department of Finance and the general public. The proposed resolution directs the Clerk/Secretary to create, post required information, and maintain the webpage on behalf of the Board.

FISCAL IMPACT:

Minimal staff time to create and maintain the webpage. The City of Palm Springs, acting in its capacity as Successor Agency to the Palm Springs Community Redevelopment Agency, is eligible for reimbursement of administrative costs of the Oversight Board, subject to current law and a cap toward the administrative costs.

THE OVERSIGHT BOARD OF THE SUCCESSOR AGENCY TO THE PALM SPRINGS COMMUNITY REDEVELOPMENT AGENCY FINDS:

SECTION 3. The Clerk/Secretary is hereby authorized and directed to respond and/or cause a response to all California Department of Finance inquiries in a reasonable manner within the time allowed by law.

SECTION 4. The Clerk/Secretary is hereby authorized and directed to create a webpage on the City of Palm Springs website, acting in its capacity as Successor Agency to the Palm Springs Community Redevelopment Agency, and post all required documents on the webpage including but not limited to: agendas, minutes, and resolutions for review by the California Department of Finance and the general public.

SECTION 5. The Clerk/Secretary is hereby authorized and directed to notice the California Department of Finance of such Oversight Board website address.

SECTION 6. The Clerk/Secretary is hereby authorized and directed to certify to the adoption of this Resolution, and file with the California Department of Finance.

SECTION 7. This Resolution shall be in effective three (3) business days after adoption.
