### ELIGIBLE BUSINESSES

- PRIVATE FOR-PROFIT
- BUSINESS MUST BE IN RIVERSIDE COUNTY
- MUST HAVE EXPERIENCED A FINANCIAL HARDSHIP AS A RESULT OF COVID-19
- SMALL BUSINESSES WITH LESS THAN 50 EMPLOYEES (MINIMUM OF 1 EMPLOYEE)
- OPERATING FOR A MINIMUM OF ONE-YEAR AS OF MARCH 1, 2020

### ELIGIBLE USE OF FUNDS

- PAYROLL/ EMPLOYEE RETENTION
- WORKING CAPITAL
- PURCHASE OF PERSONAL PROTECTIVE EQUIPMENT
- RENT OR MORTGAGE PAYMENTS
- PAYING VENDOR INVOICES

### REQUIRED DOCUMENTATION

- MUST HAVE A CURRENT CITY BUSINESS LICENSE OR COUNTY BUSINESS REGISTRATION
- MOST RECENT YEAR-END 2019 FINANCIAL STATEMENTS OR TAX RETURNS
- DOCUMENTS VERIFYING EXISTING PAYROLL
- SAFE REOPENING OR OPERATING PLAN

### INELIGIBLE BUSINESSES

- BUSINESSES THAT HAVE ACCESSED OTHER FEDERAL COVID-19 FUNDING
- NEW/STARTUP BUSINESSES WITH LESS THAN ONE (1) YEAR OF OPERATING HISTORY (AS OF 3/1/20)
- PUBLIC ENTITIES
- RESIDENTIAL OR REAL ESTATE PROJECTS
- CANNABIS-RELATED
- CASINOS/GAMBLING ESTABLISHMENTS
- ADULT ENTERTAINMENT RELATED BUSINESSES
