



BY ORDER OF THE CITY OF PALM SPRINGS

**FACE COVERINGS ARE REQUIRED IN ALL
BUSINESSES, RESTAURANTS AND ADJACENT
PUBLIC SPACES IN PALM SPRINGS.**

EXCEPTIONS TO THE ORDER:

- SEATED AT A TABLE OR BAR AT A RESTAURANT THAT IS ALLOWED TO BE OPEN. HOWEVER, IF ANY EMPLOYEE (SUCH AS A WAITER/WAITRESS, ETC.) APPROACHES THE TABLE/BAR, EACH PERSON AT THE TABLE/BAR MUST PUT ON HIS/HER FACE COVERING WHILE THE EMPLOYEE IS PRESENT AT THE BAR/TABLE.
- OUTDOORS, STANDING, WALKING, HIKING, BICYCLING OR RUNNING, AT A LOCATION OTHER THAN ON A SIDEWALK ADJACENT TO A BUSINESS ESTABLISHMENT. HOWEVER, PEOPLE MUST COMPLY WITH SOCIAL DISTANCING DURING THESE ACTIVITIES, INCLUDING MAINTAINING AT LEAST SIX FEET OF SEPARATION FROM OTHER PEOPLE. PEOPLE SHOULD ALSO HAVE A FACE COVERING READILY ACCESSIBLE.
- THOSE WITH A HEALTH CONDITION WHOSE MEDICAL PROVIDER HAS ADVISED AGAINST WEARING A FACE COVERING AND CAN PROVIDE DOCUMENTATION. SUCH PERSONS MUST WEAR A PROTECTIVE FACE SHIELD.



**ALL PERSONS ARE REQUIRED TO ENGAGE IN SOCIAL
DISTANCING BY MAINTAINING A SIX-FOOT SEPARATION
EXCEPT FOR MEMBERS IN THE SAME HOUSEHOLD.**

DEPARTMENT OF SPECIAL PROGRAM COMPLIANCE

On May 28, 2020, Riverside County released Safe Reopening Guidelines for Short-Term Vacation Rentals. Under the Guidelines, Short-Term Rentals (with exception to Homeshares) may resume operations immediately, including for non COVID-19 related use. The additional guidelines state:

Guests must adhere to local City and County Health Orders, in addition to the Good Neighbor Brochure*

- All persons are required to engage in social distancing by maintaining a six-foot separation except for members in the same household.
- Only registered guests as listed on the rental agreement should be on the premises. No additional guests or visitors allowed. ***The current emergency orders in place supersede information in the Good Neighbor Brochure and the Rental Certificate regarding daytime guests.**
- No events or group gatherings are permitted until approved by the State of California.
- Face coverings must be worn in public with exceptions below:
 - At Home
 - In the car alone or with members of their own household
 - Children under the age of 2 years, due to the risk of suffocation
 - Outdoors, standing, walking, hiking, bicycling, or running, unless on a sidewalk adjacent to a business establishment, in which case, a face covering must be worn
 - Residents with a health condition whose medical provider has advised against wearing a face covering. In such cases, a person must wear a protective face shield.
