### SUMMARY

The City Council will consider the reappointment of the City of Indian Wells representative to the Palm Springs International Airport Commission.

### RECOMMENDATION:

Reappoint Robert Wilmeth, as the City of Indian Wells representative, to the Palm Springs International Airport Commission for the unexpired term ending June 30, 2013.

### STAFF ANALYSIS:

In November, 2007, the City Council amended the Palm Springs Municipal Code to provide that each representative City nominate, and the Palm Springs City Council appoint the representative member to the Palm Springs International Airport Commission.

The City has received notification from the City of Indian Wells of their nomination of Robert Wilmeth, as the City of Indian Wells representative to the Commission, for the term ending June 30, 2013.

The City Council may choose to interview the candidate or other selection process prior to the appointment; or take no action on this appointment, and direct the City Clerk to notify the City of Indian Wells to make a further nomination.


