### SUMMARY

The City Council will consider the appointment of the City of La Quinta representative to the Palm Springs International Airport Commission.

### RECOMMENDATION:

Appoint Robert Teal, as the City of La Quinta representative, to the Palm Springs International Airport Commission for the unexpired term ending June 30, 2014.

### STAFF ANALYSIS:

In November, 2007, the City Council amended the Palm Springs Municipal Code to provide that each representative City nominate, and the Palm Springs City Council appoint the representative member to the Palm Springs International Airport Commission.

The City has received notification from the City of La Quinta of their nomination of Robert Teal, as the City of La Quinta representative to the Commission, for the term ending June 30, 2014.


### ALTERNATIVES:



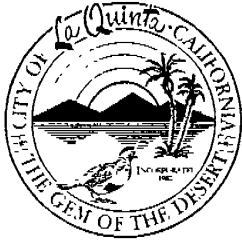
