## SUMMARY

The City Council will consider the reappointment of the City of Desert Hot Springs representative to the Palm Springs International Airport Commission.

## RECOMMENDATION:

Reappoint Jan Pye, as the City of Desert Hot Springs representative, to the Palm Springs International Airport Commission for the term ending January 31, 2014.

## STAFF ANALYSIS:

In November, 2007, the City Council amended the Palm Springs Municipal Code to provide that each representative City nominate, and the Palm Springs City Council appoint the representative member to the Palm Springs International Airport Commission.

The City has received notification from the City of Desert Hot Springs of their nomination of Jan Pye, as the representative to the Commission, for the term ending January 31, 2014.


## ALTERNATIVES:


